

Inter-State Studio's Yearbook Sweepstakes- OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. **PROMOTION DESCRIPTION:** The Inter-State Studio's Yearbook Sweepstakes ("Sweepstakes") begins on February 20, 2019 at 12:00 AM and ends on May 1, 2019 at 11:59 PM (the "Promotion Period").

The sponsor of this Sweepstakes is Inter-State Studio & Publishing Co. ("Sponsor"). By participating in the Sweepstakes, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of Entries and the overall administration of the Sweepstakes. 2. **ELIGIBILITY:** Open to legal residents of all fifty (50) United States who are 18 years or older and are responsible for the yearbook provider decision at the school they represent. This Sweepstakes is also only available to new Inter-State Studio customers for the 2019-2020 school year who do not currently have a signed agreement with Inter-State Studio when submitting their entry (the "Entrant"). Sponsor, and their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies and each of their respective officers, directors and employees (the "Promotion Entities"), are ineligible to enter the Sweepstakes or win a prize. Furthermore, the winner must sign a yearbook agreement to use Inter-State Studio as their yearbook publisher for the 2019-2020 school year.
